EO 21-15

TO ALL TO WHOM THESE PRESENTS SHALL COME GREETINGS:

AN EXECUTIVE ORDER TO PROVIDE FUNDING FROM THE HAZARD MITIGATION DISASTER FUND

WHEREAS: An effective program for mitigating the effects of future disasters upon local

governments is essential to the efficient and orderly operation of the State's

business; and

WHEREAS: Mitigation measures to prevent future damage to public facilities are necessary to

ensure the welfare of the citizens of the State of Arkansas.

NOW, THEREFORE, I, Asa Hutchinson, Governor of the State of Arkansas, acting under the authority vested in me by Ark. Code Ann. § 12-75-101, et. seq., as amended, do hereby authorize the use of Hazard Mitigation funds for the following Hazard Mitigation projects:
